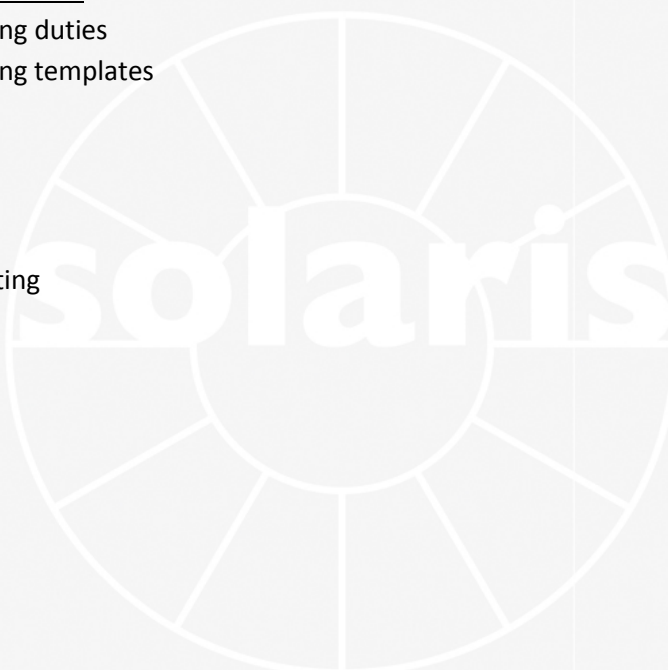

Travel advises

- Closest is Dresden (DRS, 60km), best connection to Chemnitz is by train. First train (S-Bahn) will go to Dresden main station, another train from there to Chemnitz.
- Leipzig (LEJ, 80km) is also available, same procedure by train.
- Prague (PRG, 150 km) has train and bus connections. It's a little bit tricky and needs probably half a day to Chemnitz.
- Berlin (BER, 200 km), train connection is also at the airport. To Chemnitz you would go via Leipzig. Another train will go to Chemnitz from there. There is also a direct bus connection (www.flixbus.de) but unfortunately not regularly scheduled for pandemic reasons.

Covid information

Mandatory testing or proof of immunity for persons who have been vaccinated or recovered from COVID-19:

Upon entering Germany, travellers aged twelve years or older must hold proof of the following:

- Entry from an area of variant of concern: negative COVID-19 test result. Proof of a full COVID-19 vaccination or proof of recovery from an infection is not sufficient.
- Entry from any other Country or area: a negative COVID-19 test result, proof of a full COVID-19 vaccination or proof of recovery from an infection.

This proof must be held prior to entering the country, and must be presented to the airline before departure where applicable.

On Monday, October 4th, the 7-day incidence of 35 in Chemnitz was exceeded for the fifth day in a row. Therefore, the regulations for an incidence over 35 came into force on Wednesday, October 6th:

- Mask requirement: The obligation to wear a face-to-face mask outside exists if the minimum distance of 1.5 meters cannot be maintained, as well as in all indoor areas.

- "3G Rules" for accomodation / gastronomy / visit of locations and events: Proof of a vaccination certificate, recovery certificate or test certificate, as well as contact list
